Due to CAVA @ Fresno's designation as a low-performing charter school pursuant to Education Code section 47607.2(a)(1), the Board made the following written factual findings:

1. The charter school is taking meaningful steps to address the cause or causes of low

performance, as reflected in a written plan adopted by CAVA @ Fresno's Board.

2. There is clear and convincing evidence that the charter school achieved measurable

increases in student academic achievement, as defined by at least one year's progress for

each year in school, as reflected in the attached slides.
