- Mrs. Patricia Bloodgood, ELA Coordinator gave a presentation on the annual (DELAC) District English Language Learner Program. Mrs. Bloodgood provided a written report with information on how students are designated as ELL's, reclassification process and reviewed the EL support offered for designated EL students.
- 5.2 Mrs. Osiris Serna spoke to the board regarding concerns over her children's safety on campus. She stated that she met with administration over this matter and continues to have concerns regarding the outcome of the meeting. Mrs. Hirschfield assured Mrs. Serna that her concerns are being addressed and that administration did make security changes during the morning and afternoon dismissal. In addition, starting this fall a visitor management software system will be installed and all visitors entering campus will be required to scan their Id's. This new software will also, send alerts to administration when someone of concern is on campus. Mr. Cerrillo assured Mrs. Serna that the safety of the children is at their highest priorities and asked what the district could do to address her concerns. Mrs. Serna restated that she continues to be concerned and that she does not wish to wait until something occurs. Mrs. Serna reiterated that she would like a letter documenting an incident that she reported in the fall regarding her daughter. Administration reminded her of the outcome of the meeting that took place and the inability of the district to provide a letter that stated claims that were not proven, Mrs. Serna added that she is concerned about a gentleman and gave the name. Although no incidents occurred regarding this specific person, she wanted the administration to be aware of her concern. The board president reiterated a letter could be provided stating that a concern was received but Mrs. Serna stated that a letter of that nature would not be enough, or words to that effect. The board advised Mrs. Serna to contact the

police since concerns maybe occurring at home. Mrs. Serna stated that she has contacted the police. Mr. Cerrillo stated again, that safety is the most importance to the district and that if any further concerns or incidents should arise, to please contact administration.
