

Budget Overview for the 2023-24 School Year




This chart shows the total general purpose revenue Orange Center School District expects to receive in the coming year from all sources.

The text description for the above chart is as follows: The total revenue projected for Orange Center School District is \$5,405,932.00, of which \$4,051,441.00 is Local Control Funding Formula (LCFF), \$301,462.00 is other state funds, \$631,469.00 is local funds, and \$421,560.00 is federal funds. Of the \$4,051,441.00 in LCFF Funds, \$1,179,217.00 is generated based on the enrollment of high needs students (foster youth, English learner, and low-income students).



In 2023-24, Orange Center School District is projecting it will receive \$1,179,217.00 based on the enrollment of foster youth, English learner, and low-income students. Plan Summary [2023-24]

General Information

A description of the LEA, its schools, and its students in grades transitional kindergarten–12, as applicable to the LEA.

Orange Center School District serves approximately 260 students in TK through 8th grade, preparing students for their future educational and life experiences through high-quality and engaging instruction in the area of English Language Arts, Mathematics, Social Science, Science, Technology, Physical Education, and Art. Orange Center School District serves a diverse population, with approximately four languages spoken by students and their families including English, Spanish, Hmong, and Arabic. Ethnicity data for Orange Center School District indicates that the student population is made up of approximately: 82% Hispanic or Latino, 13% Asian, 0% African American, 5% White, and 1% of two or more races. Orange Center School District's student population consists of 36% of the student population who are English Learners, and 76% of students have been categorized as socioeconomically disadvantaged. Orange Center School District employs 42 staff members. In addition to the general education program, Orange Center offers opportunities for students to explore options such as a TK-5th grade Dual Immersion Program (Spanish), Beginning Music (TK-5th Grade) Mariachi Club (6th-8th grade), Multicultural Dance Club (2nd - 8th grade), various elective options (Coding, 3D Printing, Leadership, Multicultural Studies, Beginning Mariachi, ASL, Mindfulness Exploration, Drama, Marimba, Lego Engineering, and Intro to Soccer).

Reflections: Successes

A description of successes and/or progress based on a review of the California School Dashboard (Dashboard) and local data.

Orange Center saw an increase in 2022 CAASPP scores in ELA and Math for all students as well as for English Learners. We attribute this to teachers participating in professional learning opportunities and implementing the strategies learned to address student needs across the educational environment and lessons, the district's ability to provide reading intervention to designated students in grades 1-8, access for remediation and acceleration through district-adopted programs for all EO and Dual Immersion classrooms, an initiative to assure a one-to-

one ratio of devices to students; each and every Orange Center Elementary School student from TK-8th grade has a device assigned to them during the school day. Families had the opportunity to check out devices this school year to extend learning past the school day. This has allowed families to participate in educational opportunities, practice foundational skills through District offered online academic programs, and attend online meetings and family-centered activities offered by the school. Services to improve facilities and parent communication include using a digital marquee and purchasing furniture that allow for flexible seating options to enhance the learning environment. School safety and campus climate actions include the continued use of a sign-in and out process, which includes the features of checking visitor backgrounds and alerting administration to any individuals who may put students at risk and who wish to enter the Orange Center campus. An additional day of school psychologist services was added to the plan in the 2017– 2018 school year in order to extend services in the area of social skills groups and behavior modification for students who need assistance with learning appropriate conduct, and this service continues to be offered. Orange Center has partnered with the Fresno County Superintendent of Schools Office to provide All 4 Youth counseling services. All4Youth has been providing counseling services for students since the 2018-19 school year. Currently, the district offers services with a full-time Licensed Family and Child Therapist and a Behavior Interventionist (1 day a week).due to continued needs, mental health services will continue to be provided. The District has adopted ReThink.ed SEL curriculum, lessons are embedded into the school day. The ReThink.edu scope and sequence of lessons are customized based on the student's specific needs.

Orange Center Elementary School's English Learner students are making progress toward English language proficiency. The 2022 dashboard indicates that 51.6% are making progress toward English language proficiency. The District implemented a reading intervention program to meet the needs of students who have suffered learning loss due to the COVID-19 closures and to provide support for first through first-8th grade students, as we have seen positive academic progress for students who received services. Support for students with disabilities will continue to be a priority to decrease suspension rates and close the achievement gap between all students and students eligible to receive SPED services. The District will continue to provide all of the necessary support required to fully implement a rigorous academic program: including providing access to technology equipment to families, mental health services, nutritional meals, supplemental learning materials, and additional needed services for all students.

Reflections: Identified Need

After analysis of the California School Dashboard, “status” only reports Orange Center has been able to identify the areas of greatest need among our student groups based on the six indicators reported.

Chronic Absenteeism: All Students, status "very high."

To address this need, Orange Center has contracted with a TIP Officer who will work with the administration to coordinate with parents to better inform and educate our students and parents about the importance of attendance as well as provide solutions and supports to aid in getting students to school.

Suspension Rate: All Students, status "high."

To address this need, Orange Center is working with the Differentiated Assistance team to identify alternative means to suspension in addition to proactive methods through the LEAs PBIS systems, increased social-emotional supports, and curriculum. Systems have been put into place to proactively look at data to ensure interventions and supports are implemented before the suspension takes place.

Through this partnership, Orange Center and FCSS will work together to review data and systems to identify potential causes of low performance identified by the Dashboard and then identify the next steps. In preparation for this work, Orange Center has conducted in-depth studies to determine potential root causes and address gaps as appropriate. Orange Center is in DA for Academic Achievement (ELA & Math), Chronic Absenteeism, and Suspension Rate for Students with Disabilities. Orange Center has increased monitoring of student IEP Plans to determine if additional intervention plans and supports are needed to support student learning and increased tiered support academically and behaviorally.

To continue to support academic achievement, the District will focus on data analysis, strategies for ELD, content rigor, and PLCs. Strategies will then be identified, discussed, and implemented to improve students' academic performance and academic needs. Reading intervention services will continue to serve second to eighth-grade students. The district will provide after-school math intervention for students in 2nd-8th grade students. By identifying these specific needs and addressing these needs at the student level, the District expects to find students will become more engaged. This process will improve students' confidence and provide them with a sense of empowerment and pride. The District will offer summer school that will focus on academic remediation and acceleration. This expanded learning opportunity will be offered to students in TK-7th grade during the summer break to help mitigate learning loss from the COVID-19 school closure. The District expects expanded learning through the summer will improve students' academic performance. All 4 Youths will continue to provide counseling services to students to assist with SEL needs through the summer months.

LCAP Highlights

Actions identified in the previous year's plan will be maintained and expanded. In order to continue progressing towards our goals, we will continue and enhance services to best meet the needs of English Learners, Foster Youth, Low-Income Students, and students who are not meeting grade-level standards, as measured by CAASPP and the District School Climate Survey. These actions will include Teacher training in the area of ELA, Mathematics, and Writing, Student Engagement Training, Time to Teach Discipline and Classroom Management training, and Common Core Instructional Materials Training. Increased course access, such as the Dual Immersion Language Acquisition Program, and STEAM Electives, increased opportunities for students to explore college and career readiness pathways. Increased access to technology through a computer check-out system for 6-8th grade students has been implemented as a family computer check-out system for TK-5th grade students. Services to improve facilities, parent communication, and furniture that will foster collaborative learning environments are included. School safety and campus climate actions include the continued practice of a digital sign-in and out process, including checking visitor backgrounds and alerting administration to any individuals who may put students at risk and who wish to enter campus. An additional day of school psychologist services was added to the plan in the 2017-2018 school year in order to extend services in the area of social skills

groups and behavior modification for students who need assistance with learning appropriate conduct. This will continue throughout the 2023-2024 school year. All 4 Youth counseling and behavior intervention services (which are funded through the Fresno County Superintendent of Schools Office) supplement the services provided by the District. The District will continue the reading intervention program to provide services to designated students. The District will also implement a math intervention program. Physical Education and writing support materials will be selected and purchased. The Special Education Program Improvement Team / Differentiated Assistance will meet regularly to discuss program needs to decrease the achievement gap, suspensions, and chronic absenteeism between all students and students in the SWD student subgroup.

The District would like to highlight the incorporation of Title I funds and Title I carryover funds to finance the identified goals and actions that would support effective, evidence-based educational strategies that close the achievement gap and enable students to meet the state's academic standards.

Engaging Educational Partners

The Superintendent developed materials for presentations to educational partners that contained: 1) a clear description of what LCFF and what the LCAP plan process would entail, 2) data related to the eight state priorities as a point of reference for all educational partner groups, 3) the District's current mission and vision. All of this information was compiled prior to key presentations in which input was solicited from each educational partner group. Data regarding student attendance, discipline, suspension, and assessment data was shared using the student information system and state-mandated ELPAC test data. STAR Reading STAR Math data was also used in presentations to educational partners. Presentations and corresponding materials were presented to the following educational partner groups before presenting to Orange Center School District's Governing Board:

Parent Meetings were held on April 26th, 2023 and May 4th, 2023

Orange Center Principal, CTA, teachers, classified and management/classified/confidential staff meetings were held to review and give input to the LCAP on May 8, 2023, and May 12, 2023

Orange Center CTA LCAP Meeting: May 23, 2023

Orange Center's Parent Advisory Committee, Input Meetings: January 31, 2023, February 1, 2023. The PAC & School Site Council was presented with a draft of the LCAP on May 24, 2023. All comments were responded to in writing as appropriate. The Superintendent responded to each comment in writing, as required.

The Orange Center DELAC, Input Meetings: January 31, 2023, and February 1, 2023, presented a draft of the LCAP on May 24, 2023, and again on June 2, 2022. All comments were responded to in writing as appropriate. The Superintendent responded to each comment in writing, as required.

Orange Center School District consulted with the Fresno County Superintendent of Schools SELPA regarding the district LCAP at the SELPA Operations Committee Meeting on May 8, 2023

All students, including Low-Income English Learners and Foster Youth, are given the opportunity to share concerns and ideas through facilitated discussions on March 8th, 2023, daily tiger chats, and an end-of-the-year survey.

The final draft of the LCAP was presented to the PAC, DELAC, and SSC for final consultation and approval of SSC on May 24, 2023.

The community was invited to participate in all LCAP planning meetings and reviews of the LCAP on April 26, 2023, and May 4, 2023.

In addition, community members were invited to provide input during the Public hearing held on June 14, 2023

The District has increased efforts to reach out to all educational partners. This year's process allowed for data to be shared with educational partners through parent meetings and the District website and a greater opportunity to be involved in the input process. The District does not have a classified bargaining unit. Still, classified employees, confidential management, and administrators are given the opportunity to participate in the LCAP planning process during the ALL STAFF LCAP meetings, in addition to all other stakeholder LCAP meetings that were available.

Orange Center held a public hearing on June 14, 2023: The public comments period was June 5, 2023 - June 14, 2023. Draft copies of the LCAP were available for parents and the public to obtain in the Orange Center School Office and on the district website. Feedback was accepted via email, phone, text, and handwritten notes.

Translation services were available at all meetings in English and Spanish.

The Orange Center School Board approved the LCAP and the Budget for the 2022-23 school year on June 28, 2023. Local indicators were presented in conjunction with the LCAP adoption.

A summary of the feedback provided by specific educational partners.

PAC, SSC, DELAC Feedback: Input included updated outdoor interactive spaced for students to expand their learning opportunities, hygiene, and puberty classes, and increased access to the music and performing arts.

Teacher, Classified Employees: Increased community activities, including parent universities, community opportunities, as well as other outreach events. Identified trends from teaching and certificated and confidential staff indicated a need for addressing learning loss, professional development in key areas (ELD, PLC, and depth of knowledge/rigor) for teachers and staff, and increased improvements in the school building and grounds, a need for outdoor interactive spaces and structures, increased services to address learning loss through assessment data analysis, increased support to address attendance issues and a need to provide curriculum and services and support for students and staff in the area of Social Emotional Learning and Self Care and a need for a comprehensive writing program. Feedback also included a need for a community school liaison who will facilitate relationships between the school and community and coordinate experiences to increase exposure to available services and activities.

Newly identified trends from parents and the community indicated a need for increased spaces and structures for outdoor play, a continued increase in the visual and performing arts program, and a need to provide healthy snacks for Tk/K students.

Newly identified trends from students indicated a need for increased student activities, increased awards, and appreciation opportunities, increased high-interest STEAM activities and field trips (expansion of electives to lower grades), and physical fitness and athletic opportunities for students in grades TK-4th grade.

Teacher feedback suggested that additional FTEs be added to increase services to students who are reading at two or more years below grade level through an intensive intervention program in reading will be applied in Goal 1: Action 11 Reading Intervention Teacher.

Teacher feedback included limited improvements needed to improve safety on campus.

Teacher feedback reflected a desire for increased activities for connectedness through teambuilding activities for staff and educational partners.

Staff feedback suggested a need for funding to implement a safe space in classrooms and common areas has been applied in Goal 2 Action 14: Safe Space Initiative.

Parent feedback suggested a need for improvements in the school sound system to improve student performing arts opportunities, and parent engagement activities will be applied in Goal 4: Action 4

Parent feedback suggested that a comprehensive Music program be created to address student connectivity, academic achievement, and SEL needs will be applied in Goal 5: Action 5 Music Education.

Feedback suggesting that a comprehensive Music program be implemented to address student connectivity, academic achievement, and SEL needs will be applied in Goal 5: Action 5 Music Education

Feedback suggesting that students need additional areas to play, release stress, and learn how to communicate, collaborate and practice conflict resolution are addressed Goal 2 Action 16 New Play Structure

An explanation of why the LEA has developed this goal.

When reviewing data for all students at Orange Center School, data indicates that there is a low number of students who are meeting grade level standards in ELA and Mathematics. In order to increase academic achievement highly qualified staff must be hired and retained. As a result, we expect to see increased academic achievement for all students as measured by CAASPP Math and ELA as well as increased percentages of ELs making annual growth in the ELPAC. Orange Center continues to monitor data for our low-income, English learner, and foster youth students. The LEA does not have a significant number of foster youth students to report their data within the LCAP.

Goal 1: Increase all students' academic achievement in ELA and Mathematics.

All actions within this goal contributed to increasing student achievement and the achievement of English Learners, low-income and foster youth students.

1.1 Employ and retain highly qualified staff: This action was implemented as expected. Orange Center continues to employ and retain highly qualified staff.

1.2 New Teacher(s) Support: This action was implemented as expected. New teachers' support was provided through professional development and mentoring.

1.3 Professional Development: Best Practices: This action was implemented as expected. The offered professional development focused on structures to increase student engagement, scaffolding strategies, and analyzing and assessing student learning.

1.4 Intervention- ELA 1st-3rd grade: This action was implemented as expected. A credentialed teacher provided specialized direct instruction support to students through individualized and small-group remediation lessons.

1.5 Special Education Services: This action was implemented as expected. as expected. Two SPED Teachers, a contract for a School Psychologist for two days a week, and a Speech Pathologist for 2.5 days a week were provided.

- 1.6 Data Analysis and Disaggregation Services: This action was implemented as expected. The district was able to contract services to disaggregate data and assist with data analysis.
- 1.7 Curriculum Mapping: This action was implemented as expected. Additional time was allocated to build curriculum maps and assessment calendars for the school year.
- 1.8 Supplemental Support for Students (Tutors): This action was implemented as expected. A credentialed EL coordinator and classroom teachers continued to support staff in providing remediation and acceleration activities.
- 1.9 Transportation - Intervention Program/ Expanded Learning: This action was implemented as expected using other funding sources through the Expanded Learning Program. Credentialed teachers continued to provide specialized direct instruction support to students through individualized and small-group remediation and acceleration lessons.
- 1.10 Math Intervention Program This action was partially implemented. General education credentialed teachers continued to provide specialized direct instruction support.
- 1.11 Reading Intervention Teacher 4th-8th Grade. This action was implemented as expected. There was an increased focus on individualized/small-group instruction.
- 1.12 Supplemental Writing Curriculum This action was not implemented as planned, as the faculty needed to build an ELA/ Writing Scope and Sequence prior to purchasing a program. The curriculum will be purchased this fiscal year.
- 1.13 Supplemental Curriculum - Guided Reading/ Library This action was implemented as expected. Guided reading materials and library books were provided.

Overall Successes: Most actions were implemented as expected. Designated students were able to benefit from the reading intervention program and improved toward meeting grade-level standards. Teachers used data to plan appropriate lessons and supports for all students each trimester, based on their individual assessment data, making instruction targeted to the areas of most need.

Overall Challenges: The District provided opportunities for professional development each week; however, a shortage of substitute teachers made it difficult to provide coverage during the day to conference with academic coaches. Teachers were required to meet after classes, which limited the number of professional development opportunities available during the school day. A supplemental writing curriculum was not purchased, as the overall writing scope and sequence are being created this year. The District will review available supplemental writing curricula over the next fiscal year and purchase the program we feel will best meet our needs.

An explanation of material differences between Budgeted Expenditures and Estimated Actual Expenditures and/or Planned Percentages of Improved Services and Estimated Actual Percentages of Improved Services.

The District has identified material differences due to various reasons in the actions listed:

1.2 New Teacher(s) Support: Although this action was implemented as expected, the District did not spend \$33,000.00 of the budgeted dollars towards this action, due to all professional learning opportunities being held via Zoom and after the school day. This made the need for substitute teachers almost obsolete in order to fulfill this action.

- 1.3 Professional Development: Best Practices: Although this action was implemented as expected and the services were rendered, the district has not been billed for the entire amount of services rendered in eh 2022-23 school year. The District expects to book a liability and pay this amount upon receipt of the bill.
- 1.4 Intervention Program ELA: Although this action was implemented as expected, the budgeted amount of \$51,403.00, was not spent from the original funding source that was planned. The action was funded through one-time federal dollars.
- 1.5 Special Education Services: Although this action was implemented as expected, the District spent under the amount budgeted because the District overallocated the general fund contribution by \$17,009.51 when the budget was created, based on the information available at the time of the LCAP creation.
- 1.7 Curriculum Mapping: This action was implemented as expected, the entire budgeted amount of \$5,000.00, was not spent as budgeted. The District utilized one-time federal dollars/funds from other unused dollars to support the increased need.
- 1.8 Supplemental Support for Students (Tutors): This action was implemented as expected, the District spent over the amount budgeted because of the increased need for supplemental support, and the District utilized one-time federal dollars/funds from other unused dollars to support the increased need.
- 1.9 Transportation - Intervention Program/ Expanded Learning: This action was implemented as expected, the budgeted amount of \$5,000.00, was not spent from the original funding source that was planned. The action was funded through alternate expanded learning program funds specifically allocated for transportation.
- 1.10 Math Intervention Program This action was implemented through the use of supplemental support tutors in another action. The budgeted amount needed to support this action was not utilized, as the funding was made available through one-time COVID dollars.
- 1.11 Reading Intervention Teacher 4th-8th Grade. This action was implemented as expected, however, the position for this action was not hired, the intervention was provided by the K-4 intervention teacher and the 5th-8th grade RSP/intervention teacher.
- 1.12 Supplemental Writing Curriculum This action was not implemented. the budgeted amount of 80,000.00 was not utilized and will be reserved to purchase the program in the next fiscal year.
- 1.13 Supplemental Curriculum - Guided Reading/ Library The entire budgeted amount of dollars was not utilized. However, a majority of the amount was spent.

An explanation of how effective the specific actions were in making progress toward the goal.

Goal 1: Increase student achievement of all students and subgroups. All actions within this goal contribute to increasing students' overall achievement and the overall achievement of English Learners, Low-Income, and Foster Youth Students.

1.1 Employ and retain highly qualified staff & 1.2 New Teacher(s) Support: Orange Center 2022-23 data shows the school year staffing list: 2 Interns, 2 STS, 0 misassignment, 0 vacancies. The District knows that in order to increase academic achievement highly qualified staff must be hired and retained. The LEA is committed to providing induction services to new or inexperienced teachers. Induction and intern support provided, on-the-job support for teachers new to the field, including mentoring from an experienced educator. The District provided these resources as planned.

1.3 Professional Development Best Practices: Orange Center 2022-2023. Data Source 2021-2022 Local Indicator Dashboard 5.0. The LEAs Implementation standards for all students and enable English Learners' access to CCSS and ELD standards. Professional development on structures to increase student engagement, scaffolding strategies, and analyzing and assessing student learning was provided to all teachers in the targeted areas.

1.4 Intervention Program ELA: An increased focus on small group instruction will lead to increased student achievement in reading and ELA for the identified student groups. CAASPP ELA and Math data from spring 2020-2021 and 2021-2022 indicate that there is an increase in the number of 3rd-8th grade EL and LI students who have met or exceeded the grade level standard when the test data is compared. In addition, small group intervention was provided to 45 students all in 1st- 4th grades during the 2022-2023 school year, 20% (9) of these students graduated out of the program due to meeting the goal of reading within 2 years of their grade level, and 11% (5) of the students qualified to receive SPED services, all of these students were identified as belonging to the EL and LI subgroups.

1.5 Special Education Services: In order to provide the necessary support to students who are eligible or who may become eligible for Special Education Services, Orange Center employs two SPED Teachers, and contract a School Psychologist for two days a week, and a Speech Pathologist for 2.5 days a week. District data show that all students who are eligible for special education services received all services outlined in their IEP. When comparing the SPED subgroup to the all-students group in the CAASPP the District has discovered that the distance from the standard for SWD (-98.5) is significantly lower than the all-students group (-49.2).

1.6 Data Analysis and Disaggregation Services & 1.7 Curriculum Mapping: In order to increase academic achievement the District contracted services to disaggregate data and assist with data analysis and review in order to target specific foundational skills. The District provided time for teachers to look at the data and create Curriculum Maps and Assessment Calendars. Through the skilled and purposeful use of student learning data, educators were better able to target the learning needs of each student and differentiate needs accordingly. In particular, our low-income and English Learner data show that our students identified as low-income are performing equally to All students, based on the CAASPP test. When compared to All students, the percentage of students identified as English Learners who met or exceeded standards is lower. The targeted instruction resulted in a 2% increase in ELA and Math achievement as measured on the 2021-2022 CAASPP.

1.8 Supplemental Support for Students (Tutors) & 1.9 Transportation - Intervention Program/ Expanded Learning: A credentialed EL coordinator and classroom teachers, after-school support, and transportation all work together to provide remediation and acceleration activities to students were provided. Our Low Income, Foster Youth, and English Learner students' reading and mathematics skills are brought closer to grade level through intensive support. CAASPP assessment results show that 25.88 % of EL students met or exceeded grade-level standards in reading and 17.57% of EL students met or exceeded grade-level standards in math. CAASPP assessment results show that 29.51% of SED students met or exceed grade-level standards in reading and 13.49% of SED students met or exceeded grade-level standards in math. In particular, our low-income and English Learner data show that our students identified as low-income are performing equally to All students, based on the CAASPP test. When compared to All students, the percentage of students identified as English Learners who met or exceeded standards is lower although positive gains were met in both ELA and Math for this subgroup when comparing CAASPP scores for the past 2 years. The targeted supplemental instruction resulted in a 2% increase in ELA and Math achievement as measured on the 2021-2022 CAASPP.

1.10 Math Intervention Program- Our Low Income, Foster Youth, and English Learner students' reading and mathematics skills are brought closer to grade level through intensive support tutors and supplemental remediation, intervention, and acceleration practice through Lexia, Power up, Freckle Math, Freckle ELA, and IXL. In particular, our low-income and English Learner data show that our students identified as low-income are performing equally to all students, based on the CAASPP test (2021-2022) When compared to All students, the percentage of students identified as English Learners and Students With Disabilities (SWD) who met or exceeded standards are lower. The targeted supplemental instruction resulted in a 2% increase in ELA and Math achievement as measured on the 2021-2022 CAASPP.

1.13 Supplemental Curriculum- The District provided reading material to supplement the core and allow students to increase their reading proficiency through the STAR Reading/ Accelerated Reading Program. Our Low Income, Foster Youth, and English Learner students' reading and mathematics skills are brought closer to grade level through intensive support. CAASPP assessment results show that 25.88 % of EL students met or exceeded grade-level standards in reading and 17.57% of EL students met or exceeded grade-level standards in math. CAASPP assessment results show that 29.51% of SED students met or exceed grade-level standards in reading and 13.49% of SED students met or exceeded grade-level standards in math. In particular, our low-income and English Learner data show that our students identified as low-income are performing equally to All students, based on the CAASPP test. When compared to All students, the percentage of students identified as English Learners who met or exceeded standards is lower although positive gains were met in both ELA and Math for this subgroup when comparing CAASPP scores for the past 2 years. The targeted supplemental instruction resulted in a 2% increase in ELA and Math achievement as measured on the 2021-2022 CAASPP.

CAASPP Data for Students with Disabilities was added to the metric based on the differentiated assistance team recognizing a need to bridge the academic achievement gap between all students and SWD.

2.1 Home-to-School Transportation: This action was implemented as expected. Rural school home-to-school transportation was provided by Orange Center staff and will continue to provide home-to-school transportation.

2.2 Maintenance/Repair to School Facility: This action was implemented as expected. Facilities, furniture, and school grounds were well maintained. Staff continued to monitor the school environment and repaired the facility.

2.3 Parent Involvement Opportunities: This action was implemented as expected. Parent Involvement opportunities were provided through administration and parent engagement team offerings.

2.4 Preventative Healthcare Measures- LVN: This action was implemented as expected. A credentialed LVN continued to support students and parents by providing preventative care and education.

2.5 Positive Behavior Intervention and Support Program: This action was implemented. The PBIS team continued to provide Positive Behavior Intervention and support activities.

2.6 Supplemental Services- Socio-emotional Health: This action was implemented. The School Psychologist continued to provide SEL and Behavior Intervention and support activities for identified students.

2.7 SEL Curriculum & Support Materials: This action was implemented. Site teachers and administration continued to provide SEL and Behavior Intervention lessons, and support activities for students.

2.8 California Healthy Youth Act Course: This action was implemented. Through a contract with FCSS, the district continued to provide lessons and resources required by the Healthy Youth Act Course for students.

2.9 TIP Officer: This action was implemented. Through a contract with FCSS, the district continued to provide support and guidance to district parents and administration through the collaboration of a TIP officer.

2.10 FCSS RN Contract- Supplemental Days. This action was implemented as expected. A credentialed RSN continued to support students and parents by providing preventative care and education.

2.11 Supplemental PE Curriculum. This action was implemented as expected. P.E. materials and curriculum were provided.

2.12 Classroom Furniture. This action was implemented as expected. Classroom furniture was provided.

2.13 Outdoor Seating. This action was implemented as expected. Outdoor seating was provided.

2.14: Social-Emotional Education. This action was implemented as expected. Site teachers and administration continued to provide SEL and Behavior Intervention lessons, and support activities for students.

2.15 Safe Space Initiative. This action was implemented as expected. Flexible seating, materials, and supplies were provided.

Overall Successes: All actions were implemented as expected. Targeted students were able to benefit from the support provided to students and families through the additional LVN and RSN contracts, with respect to communication, testing, and preventative measures in order to increase attendance. Parents and students were able to receive medical support information, vaccines, and COVID testing on-site which provided increased opportunities for medical services. The PBIS team was able to implement positive behavior initiatives to help improve negative behaviors by focusing on desired behaviors. The District has completed a facilities maintenance plan, in order to prioritize needed improvements, campus-wide. The District was able to successfully implement an SEL program on campus, using student, self-evaluation surveys, in order to provide SEL lessons that focus on our student's needs based on state-identified domains.

Overall Challenges: The District provided all actions however, due to a large number of students who were required to quarantine due to COVID-19 infection or exposure throughout the first 4 months of the school year, efforts towards improving attendance were difficult. Absences were often indicated to be due to illness. The Tip Officer worked with the district designees to communicate with parents regarding unexcused absences and tardies and truancy.

Due to increased absences because of illness, it was difficult to reach all students with actions that were provided, however, the district will continue to implement all actions based on the following data: Our Low Income, Foster Youth, and English Learner students' reading and mathematics skills were brought closer to grade level through the implementation of the actions in this goal. CAASPP assessment results show that 25.88 % of EL students met or exceeded grade-level standards in reading and 17.57% of EL students met or exceeded grade-level standards in math. CAASPP assessment results show that 29.51% of SED students met or exceed grade-level standards in reading and 13.49% of SED students met or exceeded grade-level standards in math. In particular, our low-income and English Learner data show that our students identified as low-income are performing equally to All students, based on the CAASPP test. When compared to All students, the percentage of students identified as English Learners who met or exceeded standards is lower although positive gains were met in both ELA and Math for this subgroup when comparing CAASPP scores for the past 2 years. .

2.1 Home-to-School Transportation: To ensure student engagement in a rural school home to school transportation is required. The District provided transportation to 100% of our in-district students.

The District provided parent engagement opportunities this year, such as folkloric dance performances, academic awards nights, parent engagement and family learning nights, winter program, fall cultural night activities, family reading nights spring play, open house, and back-to-school nights.

The District provided these services as planned. These actions work together to improve the physical and mental well-being of our Low Income, Foster Youth, and English Learner students. The District's chronic absenteeism data shows that the number of EL students who were chronically absent has increased by 30% and the number of LI students who were chronically absent increased by 4.5%. The District's attendance rate data shows a 6% decrease in attendance rates for EL students. The District's suspension rate data shows that the number of suspensions has increased when compared to the previous year for EL students (5% and LI students 4.5 % respectively). Due to the COVID-19 pandemic restrictions being lifted in the middle of the academic year, the District expects this data to normalize, as the return to school, and attendance requirements, are returning to previously expected norms. Data for Foster youth are not available due to the small number of students in this subgroup.

2.8 California Healthy Youth Act Course: The District provides a CHYA- California Healthy Youth Act course for students in one of their middle school years. LEA data shows that the District met the state requirement in alignment with CHYA.

A description of any substantive differences in planned actions and actual implementation of these actions.

Goal 3: Every student will receive rigorous, research-based instruction aligned to Common Core State Standards. All English Learners received English Language Development (ELD) that is aligned with the current ELD standards. The District provided instruction as indicated in this goal. While reclassification rates did not improve as anticipated, we believe that these were impacted by returning to school after the pandemic and that the best course of action is to implement the actions as planned.

3.1 Provide Hands-on Learning & STEAM Experiences: General education teachers continued to integrate hands-on learning and STEAM experience in the area of STEAM in their lessons the number of experiences was less than expected due to a high number of absences and students being out causing more time for reteaching to take place.

3.2 Professional Learning: This action was implemented as expected. The offered professional development focused on common core and ELD standards to increase student academic achievement.

3.3 Supplemental Materials: This action was implemented as expected. STEAM materials were provided.

3.4 State-Adopted Curriculum This action was implemented. The District provided all teachers and students with access to all core academic curricula and teachers' editions.

Overall Successes: The District was able to provide teachers with the opportunity to order all material resources listed in order to support the actions above.

Overall Challenges: The District provided opportunities for all students to receive rigorous research-based instruction that is aligned with the Common Core Standards however, due to a high number of absences, due to illness and quarantine earlier in the academic year, it was challenging to incorporate supplemental lessons and activities into planned lessons.

The District has identified material differences due to various reasons in the actions listed:

3.1 Provide Hands-on Learning & STEAM Experiences: This action was implemented as expected. The District spent under the amount budgeted for this action. To the extent possible, the staff was able to provide STEAM Experiences. Although this action was implemented, the number of experiences was limited causing not all funds to be spent.

3.2 Professional Learning: CC Standards Although this action was implemented as expected and the services were rendered, the District spent under the budget for this action. The District has not been billed for all of the services performed in the 2022-2023 school year. The District expects to book a liability and outstanding amounts upon receipt of the bill.

3.3 Supplemental Materials: This action was implemented as expected, the District spent over the amount budgeted for this action due to more in-class experiences that were planned and less out of classroom experiences being provided. Also, the cost of materials increased, and the district did not account for this in the budget in this area.

3.4 State Adopted Curriculum: This action was implemented as expected, The District spent under the amount budgeted for this action. The District provided all materials to students required, however, the District overbudgeted in this area. The supplemental materials provided were funded through other one-time federal dollars.

OC reclassification rates did improve as anticipated as demonstrated in the metric, the reclassification rate of EL and LI students was positively impacted by the actions and services funded through this goal, and the best course of action is to continue to implement the actions as planned. Due to the small number of foster youth, data is not available for this subgroup. Our Low Income, Foster Youth, and English Learner students' reading and mathematics skills were brought closer to grade level through the implementation of the actions in this goal. CAASPP assessment results show that 25.88 % of EL students met or exceeded grade-level standards in reading and 17.57% of EL students met or exceeded grade-level standards in math. CAASPP assessment results show that 29.51% of SED students met or exceed grade-level standards in reading and 13.49% of SED students met or exceeded grade-level standards in math. In particular, our low-income and English Learner data show that our students identified as low-income are performing equally to All students, based on the CAASPP test. We anticipate that EL Reclassification rates will continue to improve. Due to the COVID-19 pandemic, a high number of students were absent from school throughout the year when compared to historical data making it difficult to measure academic growth. The District will continue to implement this action.

Orange Center saw an increase in 2022 CAASPP scores in ELA and Math for all students as well as for English Learners. We attribute this to teachers participating in professional learning opportunities and implementing the strategies learned to address student needs across the educational environment and lessons, the district's ability to provide reading intervention to designated students in grades 1-8, access to remediation and acceleration through district-adopted programs for all EO and Dual Immersion classrooms, an initiative to assure a one-to-one ratio of devices to students; each and every Orange Center Elementary School student from TK-8th grade has a device assigned to them during the school day. Families had the opportunity to check out devices this school year to extend learning past the school day.

3.1 Provide Hands-on Learning & STEAM Experiences: All grade levels participated in field trips that exposed students to hands-on learning & STEAM experiences, as COVID restrictions allowed. Our Low Income, Foster Youth, and English Learner students' reading and mathematics skills are brought closer to grade level through exposure to Hands-on Learning. CAASPP assessment results show that 25.88% of EL students met or exceeded grade-level standards in reading and 17.57% of EL students met or exceeded grade-level standards in math. CAASPP assessment results show that 29.51% of SED students met or exceed grade-level standards in reading and 13.49% of SED students met or exceeded grade-level standards in math. In particular, our low-income and English Learner data show that our students identified as low-income are performing equally to All students, based on the CAASPP test. When compared to All students, the percentage of students identified as English Learners who met or exceeded standards is lower although positive gains were met in both ELA and Math for this subgroup when comparing CAASPP scores for the past 2 years. The targeted supplemental instruction resulted in a 2% increase in ELA and Math achievement as measured on the 2021-2022 CAASPP.

3.2 Professional Learning: CC Standards: All teachers on staff participated in monthly professional development opportunities to learn how to best deliver instruction in the area of common Core Standards to students.

3.3 Supplemental Materials: STEAM: All teachers were provided with materials in order to deliver STEAM lessons to students.

Goal 4: Increase the number of parents, families, and community education partners that participate in activities that are directly related to the educational experiences of their students. All actions within this goal contributed to the increasing numbers of parents, families, and community education partners.

4.1 Parent Engagement Activities - This action was implemented as expected to the extent possible. Parent Involvement opportunities were provided through administration, the expanded learning program, and parent engagement team offerings. Although not all funds were spent, the opportunities indicated were implemented however, due to COVID restrictions, the amount of opportunities was limited during the first half of the school year.

4.2 Communication with Parents and Community- This action was fully implemented. Orange Center continues to use multiple measures to communicate with parents including phone dialers, text messages, notes home, and peach jar email communications.

4.3 Communication: Spanish and Hmong Speaking Liaisons- This action was partially, implemented. Orange Center continues to employ and retain Hmong and Spanish-speaking Liaisons in order to provide communication to identified student groups.

4.4 Performing Arts Program - This action was partially completed. Orange Center provides music instruction through contracts with music service providers in order to provide music instruction and offers elective courses that enhance students' experiences in the area of performing arts.

Successes: Most actions were implemented as expected. Designated students were able to benefit from the music and performing arts program and an increased number of families were able to participate in activities that enhanced their children's educational experiences. The District utilized communication programs in order to provide increased communications to all educational partners.

Challenges: The District provided music and performing arts opportunities and various language liaisons; however, a shortage of music teachers and bilingual staff in the Hmong language made it difficult to hire staff for the entire year.

The District has identified material differences due to various reasons in the actions listed:

4.1 Parent Engagement Activities - This action was implemented as expected, the District spent under the amount budgeted for this action. The District provided engagement activities to the extent possible while following COVID restrictions. The activities that were planned did not cost as much as originally expected due to COVID limitations for the first half of the year.

4.2 Communication with Parents and Community- This action was implemented as expected, the District spent under the amount budgeted for this action. This action was supported through the use of other one-time federal dollars.

4.3 Communication: Spanish and Hmong Speaking Liaisons- This action was partially implemented as expected, the District spent under the amount budgeted for this action.

4.4 Performing Arts Program - This action was partially implemented and the district did not spend the entire amount budgeted for this action.

An explanation of how effective the specific actions were in making progress toward the goal.

Goal: Increase the number of parents, families, and community education partners that participate in activities that are directly related to the educational experiences of their students.

Data from recent parent surveys and educational partner feedback indicate that families of all students continue to need opportunities to become aware of vital school information and ways to support their children surrounding academic and educational topics. The District was able to increase support and opportunities to facilitate increased participation in school-sponsored meetings and activities through actions 4.1, 4.2, and 4.3 as described above. The district was able to increase parent engagement attendance by providing multiple ways of communicating information regarding said activities. Data indicates that our Low Income, Foster Youth, and English Learner students' reading and mathematics skills were brought closer to grade level through the implementation of the actions in this goal. CAASPP assessment results show that 25.88 % of EL students met or exceeded grade-level standards in reading and 17.57% of EL students met or exceeded grade-level standards in math. CAASPP assessment results show that 29.51% of SED students met or exceed grade-level standards in reading and 13.49% of SED students met or exceeded grade-level standards in math. In particular, our low-income and English Learner data show that our students identified as low-income are performing equally to All students, based on the CAASPP test. When compared to All students, the percentage of students identified as English Learners who met or exceeded standards is lower although positive gains were met in both ELA and Math for this subgroup when comparing CAASPP scores for the past 2 years.

4.1 Parent Engagement Activities: The District has increased the number of in-person parent engagement activities available, as COVID restrictions have lifted midyear. The number of parents participating in activities increased when compared to last school year.

4.2 Communication with Parents and Community: The District increased the means of communication by continuing to provide Peachjar with all other means of communication that the District offers. This has increased the number of email addresses that were made available to the District, thus increasing measures in which to communicate with parents.

4.3 Communication: Spanish and Hmong Speaking Liaisons: Spanish and Hmong Liaisons have assisted in communicating with parents throughout this school year, specifically to communicate regarding health and attendance issues. The ability to communicate with parents who speak Hmong and Spanish has resulted in more parents participating in educational experiences at Orange Center School.

4.4 Performing Arts Program - Title I Carry Over Students have had the opportunity to perform in various capacities through the OC Arts program: Florklorico, Marimba, Mariahch, and drama. Drama and Marimba are new activities that the district has been able to implement through the execution of this action. These increased opportunities have resulted in more parents participating in educational experiences at Orange Center School.

All Identified students were given opportunities to access 21st Century skills and a broad course of study that would prepare them for high school success. The District provided instruction as indicated in this goal. While CAASPP did improve slightly, as anticipated, we believe that the amount of growth was impacted by students being absent due to COVID-19 exposure and illness. We will continue to implement the action as planned.

5.1 Instructional Technology Support: This action was implemented as expected. Orange Center continues to employ and retain an instructional technology coordinator and contract for technical support services.

5.2 Extended Learning: This action was implemented as expected. Extended learning opportunities were offered and provided to identified students and was provided through elective class offerings, expanded projects, community activities, and the expanded learning program.

5.1 Instructional Technology Support: The District provided staffing to provide technical support in the area of instructional maintenance and upkeep to all staff and students as planned.

Goal 6: Increase student achievement of English Language Learners All English Learners and teachers received services and training indicated in this goal. While reclassification rates did not improve as anticipated, we believe that these were impacted by returning to school after the pandemic and that the best course of action is to implement the actions as planned.

- 6.1 English Learner Coordinator: This action was implemented as expected. Orange Center employs and retains an English Learner Coordinator and provides support services to identified students.
- 6.2 Professional Development: ELD: This action was implemented as expected. The district offered professional development opportunities that focused on research-based strategies targeted for language acquisition and development for teachers and support staff.
- 6.3 Supplemental Curriculum and Supplies: ELD & Dual Immersion: This action was implemented as expected. supplemental curriculum and supplies were provided.
- 6.4 Instructional Aides: This action was implemented as expected. Orange Center employs and retains instructional aides and provides support services to identified students.

Overall Successes: Most actions were implemented as expected. Designated students were able to benefit from the EL Coordinator services as the service provider was able to assess and monitor all EL students as needed during the 22-23 school year. The adoption of I- Station en Espanol has increased access to an online curriculum that provides intervention and expanded lessons.

Overall Challenges: The District provided increased opportunities for language support for identified students however, absences due to COVID-19 illness and quarantine decreased the amount of time and exposure to all programs and supports that were available to students.

- The District has identified material differences due to various reasons in the actions listed:
- 6.1 English Learner Coordinator: This action was implemented as expected, the District spent over the amount budgeted for this action. Due to the increased need for supplemental support hours for a safe dismissal and additional academic support. time federal dollars to support increased needs.
- 6.2 Professional Development: ELD: This action was implemented as expected, and the District spent under the amount budgeted for this action. The need arose to provide training and resource materials to staff in the area of ELD strategies and was supported in other actions under goal 1.
- 6.3 Supplemental Curriculum and Supplies: This action was implemented as expected, and the District spent under the amount budgeted for this action. The District was able to use other one-time dollars to implement this action.
- 6.4 Instructional Aides: The District implemented this action however the amount budgeted for this action was not utilized, as additional tutors were provided through another action in goal 1.

An explanation of how effective the specific actions were in making progress toward the goal.

Goal: Increase student achievement of English Language Learners
Orange Center Elementary School's English Learner students are making progress toward English language proficiency. The 2022 dashboard indicates that 51.6% are making progress toward English language proficiency. The District implemented a reading intervention

program to meet the needs of students who have suffered learning loss due to the COVID-19 closures and to provide support for first through first-8th grade students, as we have seen positive academic progress for students who received services.

When reviewing data for English Language learner students at Orange Center School, data indicates that there is a higher number of students who are meeting grade-level standards in ELA and mathematics when compared to the previous year. Although the District has seen improvement, the District will continue to provide additional student support services, staff, and professional development activities to augment the educational program for our English learners. While EL student achievement did improve as anticipated, we believe that a higher number of students could have improved academically and that the slight improvement was impacted by returning to school after the pandemic, and that the best course of action is to continue to implement the actions as planned.

6.1 English Learner Coordinator: The EL Coordinator was able to assess and monitor all EL students as needed during the 22-23 school year.

6.2 Professional Development: ELD: All teachers had the opportunity to participate in professional learning opportunities that encompassed how to best incorporate ELD strategies in the classroom.

6.3 Supplemental Curriculum and Supplies: ELD & Dual Immersion: All teachers were given the opportunity to purchase supplemental supplies for ELD instruction and in the Dual Immersion Program.

6.4 Instructional Aides: Instructional aides were retained and worked with students who needed additional support in order to mitigate learning loss.

The Local Control Funding Formula (LCFF) requires local educational agencies (LEAs) to engage their local educational partners in an annual planning process to evaluate their progress within eight state priority areas encompassing all statutory metrics (COEs have 10 state priorities). LEAs document the results of this planning process in the LCAP using the template adopted by the State Board of Education.

The LCAP development process serves three distinct, but related functions:

- **Comprehensive Strategic Planning:** The process of developing and annually updating the LCAP supports comprehensive strategic planning (California *Education Code* [EC] Section 52064[e][1]). Strategic planning that is comprehensive connects budgetary decisions to teaching and learning performance data. These actions are being provided on an LEA-wide basis and we expect/hope that all students with less than a 100 percent attendance rate will benefit. However, because of the significantly lower attendance rate of low-income students, and because the actions meet needs most associated with the chronic stresses and experiences of a socio-economically disadvantaged status, we expect that the attendance rate for our low-income students will increase significantly more than the average attendance rate of all other students. (Measurable Outcomes [Effective In])
